PART I: JURISDICTION

Stipulated by Election Code article 11.4: "Election Board decisions may be appealed in writing to the Undergraduate Students Association Judicial Board. Initial petitions for hearing shall be made by 5:00 p.m. on the second (2nd) official school day following said decision."

USAC Election Board released decisions on complaints #C67, C68, C69, C70 and C71S2018 on 5/15/18 at 6:37 pm. Richard Et Al has submitted this petition on 5/17 well within the window to petition via election code article 11.4

Official Order 18-4 stipulates, "The JUDICIAL BOARD requests the USAC Election Board to issue a reasonable sanction in accordance with Election Code Article 11.3.5.a-d. After an admission of guilt from the USAC Election Board for failing to issue a sanction in #C59-S2018 for attempted voter coercion."

PART II: VIOLATIONS

Enumeration of Violations

In Official order 18-4 "The JUDICIAL BOARD requested the USAC Election Board to issue a reasonable sanction in accordance with Election Code Article 11.3.5.a-d. After an admission of guilt from the USAC Election Board for failing to issue a sanction in #C59-S2018 for attempted voter coercion". USAC Election Board has failed to issue a reasonable sanction for a validated attempt of voter coercion by Bella Martin and Victoria Solkovits in accordance with Election Code Article 11.3.5. A-d.

USAC Election Board has failed to issue a *reasonable* sanction on complaints #C67, C68, C69, C70, and C71 for a validated invasion of voter privacy based on Election Code article

11.3.5. a-d. and based on USAC Election Board's previously issuing sanctions for invasion of voter privacy.

PART III: RAMIFICATIONS

By failing to issue reasonable sanctions for complaints #C67, C68, C69, C70, and C71 USAC Election Code has failed to uphold the fairness and integrity of the 2018 USAC Election Process.

By failing to abide by Official Order 18-4 by not issuing a reasonable sanction in regards to complaint #C59 USAC Election Board has failed to represent the will of the Undergraduate Student Association body and failed to uphold a fair and free election.

PART IV: REMEDY SOUGHT

Given the findings in complaints #C67, C68, C69, C70 and C71, we seek for USAC Election Board to issue a reasonable sanction to be given in response to all complaints (C67-C71).

Given Official Order 18-4, we seek for USAC Election Board to issue a reasonable sanction for complaint #C59.
