I. A. Call to Order

-McKesey called the meeting to order at 6:07 pm.

General Representative - Nelson Saldaña

-Saldaña said that he would be training as an orientation counselor over the summer. He said that for that reason he may not be able to attend the rest of the summer meetings. He said that he wanted to let Council know. He said that he will try to be at the meetings when he can. He also said that he spoke to some orientation counselors about the idea of USAC speaking at counselor training and tabling during orientation events.

External Vice President

-Kaczmarek said that he had just gotten back from Miami. He said that he attended the Jobs With Justice convention. He said that Jobs With Justice is an organization that works on labor oriented campaigns. He said that they bring community organizations together to launch citywide campaigns. He said that the workshops at the event were very interesting. He said that he will put together written reports on future events like this to deliver to Council. He said he would also like to mention that the Supreme Court came down with decisions on the University of Michigan affirmative action cases. He said that they ruled that the affirmative action policy of the University of Michigan's Law School was legal, but they struck down the point system used in the University of Michigan's undergraduate admissions policy. He said that UCSA sees the decision as good mainly because it could have been much worse. He said that there will be some setbacks but they are hopeful. He said that Chancellor Carnesale has made no statement as of yet.

Community Service Commissioner

-Schreiber said that during the previous weekend his staff had a retreat. He said that it went very well. He said that they want to have a day on campus to promote community service. He said that he hopes USAC could be involved in such a day. He said that it would be in fall quarter some time.

President

-McKesey said that she had had her first official staff meeting. She said that they talked about the presidential internship program and would like to include two parts in the internship. She said that one part would be for those interested in working in a specific office and the other would be for those interested in student government generically. She said that all of the interns would come together for bi-weekly workshops on different topics. She said that they will need the other Council members' help to make it all work. She said that they also discussed ideas for Welcome Week. She said that there is usually an open house. She said that they wanted to have a theme each day and that one of the proposed themes was community service. She asked Council to start thinking about other themes. She said that she will also be contacting those who turned in an application for a presidential appointment but didn't receive an appointment to see if they would like to participate in the internship program.

IX. Old Business

*USAC Retreat: Tentative Agenda and Location

- -McKesey said that she has a draft of the goals that people have said they would like to accomplish at the retreat.
