IV. Public Comments

-As a student leader in 7000 solidarity and she was overwhelming respect for the resolution and needs kinks and parts and specificities that needs time and attention it deserves to have attention. It seems to be an us and them relationship and a survivor and assailant. However, their silence keeps survivors down. It keeps from speaking out against what happens. This is not a violence issue or verbal issue its an everyday issue in classroom and online. If you are willing to not give survivor a time of day and ask what were they wearing or drinking, you are not a responsibile student leader and you have no space in this room. Sadly she has seen to much of that.

V. Special Presentations

A. Students for Justice in Palestine

present after the positive investment hearing there were a lot of misconceptions about Students for Justice in Palestine. She states they are a solidarity organization and advocacy group through acting in solidarity with the Palestinian people and support Palestinian rights. They do not take sides on Palestinian political issues, such as who they should elect in government because they are students in UCLA studying in America and it is not their place to speak on behalf of Palestinians but rather stand behind them. Their main goal is to support three basic Palestinian rights. First, the right to not live under occupation in the West Bank and Gaza. The second is the right of Palestinian refugees to return to their homelands. Third, the right of equal law and equal treatment of Palestinian citizens of Israel. She reads their mission statement. SJO UCLA is a diverse group of students all united on one basic principle: our dedication to Palestinian rights. They reject all forms of discrimination and oppression including racism, sexism, homophobia, ableism, anti-Semitism and Islamophobia. -They ask divestment for any companies that are profiting off human rights abuses. It's also divestment from the prison industrial complex and fossil fuels. She shows a picture of divestment from South African apartheid. This is an economic tool to put economic pressure on a company for them to stop engaging in any unethical practices. -Why divest? Palestinian civil society issues a call in 2005 for solidarity activists across the world to push for divestment to protect human rights. She talks about the caterpillar study, where Caterpillar has been supplying Israel with weapons such as the bulldozers known to destroy homes and farms. She shows a picture of a Palestinian family as their home is being demolished. They also destroy lives, such as Rachel Corrie an American activist in solidarity with Palestine. It's not that these companies are just selling products to Israel, but these companies know exactly what they are doing and many human rights organizations contacted these companies. They began publicly condemning Caterpillar since 1989 and since 2001 they have sent over 50,000 letters decrying the use against humans. Caterpillar is clearly profiting and have chosen not to do anything, and that's why they want to divest. -What will they be asking of USAC? They recommend that UC Regents to divest. They want

to recognize that companies our university invests in are profiting from violence against

Palestinians. They are asking to consider what investing in violence means to some students in campus.

- -What are they NOT asking for? They are not asking to endorse SJP, agree with everything SJP stands for, or come up with solutions for the conflict.
- -Divestment myths include: "the purpose of divestment is to harm Israel or the Israeli people." The purpose is not to harm anyone, but they want to put economic pressure to stop unethical behavior. "Divestment is intended to harm Jewish students on campus" They absolutely do not want to harm jewish students, there are many that agree. The third is that "Divestment targets anything and everything Israeli" which is wrong because we don't want to divest from Tiva, a pharmaceutical company. The last myth is that "divestment singles out Israel/gives Palestinians special status over others." This is not true.
- -Agatha opens up the floor to questions.
- -Ramalho asks for a copy of the presentation.
- -Agatha says for sure.
- -Naameh asks if all the companies are American companies.
- -Agatha states they are only targeting American companies because at an American university they feel that they some form of leverage.

B. ASUCLA Board of Directors

- -Precious, Joel, and Adam introduce themselves as student reps of ASUCLA. They give an overview of what ASUCLA has been doing.
- -Precious states they added the Student Engagement Committee and they just had a t-shirt campus with over 80 submissions and great to engage students with ASUCLA, and thanks Singh. They have been talking about a reusable mug idea to be more innovative and to feel more attached and able to use them, perhaps through changing design. As for the black experience committee and partnered with Afrikan Student Union to reveal a mural and get it in a timely and efficient fashion. They have been working with Student Media Summit to talk with finances to show their support. They hope their relationship with USAC stays transparent and healthy.
- -Joanino states he was the Finance Committee meeting and saw the presentation of the redesign of Ackerman.
- -Adam stated that it was a huge project to consider, knowing it's going to take years to complete and it will happen level by level. There have been talks about Space project evaluating what kind of space students want on campus and interviewed and surveyed students. The main source of space is that study space and white noise to hang out and focus. They know that the A level of Ackerman where all the books lie is a huge chunk of underutilized space. They want to transform the bookstore area to a study lounge and union feel.
- -Singh asks if it's the book area directly across the ATM?
- -Adam states yes. They said they must have noticed changes in Ackerman such as the B level with more boutique areas to make that experience better. Precious imagined the Black Experience Mural on the first floor such as Wolfgang Puck. They've seen a lot of things change and that will change for the better.
- -Hall reiterates that in the spirit of engagement to partner with student organizations primarily focused on art and activism and the history that UCLA has and portraying it at UCLA.
- -Adam stated it was a great idea that Singh mentioned prior. They want to ensure that their student union wants to be uniquely UCLA, and that is definitely an objective BOD shares.

- -Naameh asks if it would be cycling the art on the wall or adding more?
- -Joel stated that they utilize it in Kerkhoff and spaces like that don't have art all the time to ensure there is transfer in the art gallery and state rooms as far as continuous plan with the redesign plan. They want to make it a Bruin student life with blue and gold with history and traditions for ongoing projects.
- -Trumble states that CAC controls all the art in Kerkhoff, separated by the ASUCLA.
- -Zimmerman stated that it's interesting that in the union it's all student art and there is a contest and those pieces get displayed in the union. They are actually all student art pieces.
- -Joel stated that on Friday there meeting would be a finalization of the quarter and overview of what the committee has completed.
- -Naameh asks what is going on with the sleeping pods
- -Adam states they are studying various alternatives and its clear students are sleep deprived and naps are efficient to power. They are studying various alternatives such as pods, recliner chairs, a room, and a lot of alternatives that students get the sleep they desperately need since its a huge toll on health and academics.

A. President

- -Naameh asks what the undie run campaign will be like
- -Badalich stated that 7000 in solidarity won't be endorsed on it. Badalich stated that its a play off slut walk, when a Toronto cop stated that if they didn't want to get raped they would't have dressed a certain way. Badalich stated 7000 in solidarity won't be in underwear, but CARE SOS has been talking about Undie Run.
- -Joanino said they'll talk more about it.
- -Joanino stated that Jasso and Roy will set a physical contract that will specifically outline principles of endowment process. He contacted UCLA development and wanted to be best educated on exactly how the mechanism works.

B. Internal Vice President

-Oved stated that IVP hosted USAC townhall. He thanks Naameh for starting the conversation. Oved thanks all the council members that came and it was a great way to balance all these different perspectives. It was a productive conversation and they want to host more throughout the year.

C. External Vice President

-Hall states that the Prison Divestment Resolution this week and want to postpone it for Winter Quarter which will be great for outreach. She apologizes for not being able to go townhall because her laptop was stolen yesterday, and she reminds people to keep their doors locked. Hall stated she may lag in responding to emails.

D. Academic Affairs Commissioner

- -Ramalho thanks everyone who came out to last Stress Free Day. Hopefully next quarter they will be doing with SWC for a large stress free day. A lot happened with AAC, and just got information from Pat Turner on the diversity requirement and met with Hall and Bruin Lobby Corp director to start campaign movement to lobby faculty about a diversity requirement. They will be able to gage what faculty think to move forward. Joanino and Ramalho had a discussion with the academic senate. He also emailed council about a video. Online education and the survey has been approved and beginning next year they are starting focus groups to talk about online education. Lastly, next quarter AAC will be focusing on tutoring services and he wants to update that to make sure it's accurate and transfer students have it available next quarter.

They left paper and tape with people to write on and it's completely filled up. It's amazing and awesome from 5-7 with a movie called No Lies. It's amazing because a lot of administrators came and self defense people and ORL. She is very proud and culmination of all the work to show survivors that students stand in solidarity and to show students that generally fall under the category of survivors and students who have no idea. She stated that a football player came through and didn't know that it happened and signed the pledge. She is very proud and invites everyone to go down. Badalich stated that if you see a survivor it would be really weird and it's not meant to be something that they are known for because it's not their identity. SWC is having their silent disco at 7:30 in Powell, and on Sunday they are having yoga at Tsunami at 7:30 pm.

G. Administrative Representative

- -Zimmerman stated that 24 hour study starting Wednesday and Thursday and starting Sunday in the union and there will be a van and shuttle service from bruin plaza to apartment or dorm room. The van shuttle starts at 1am and goes until 7am.

B. A Resolution in Support of UC-Wide Title IX Education, Sexual Assault Policy Reform, and Sexual Assault Resource Improvement

A Resolution in Support of UC-Wide Title IX Education, Sexual Assault Policy Reform, and Sexual Assault Resource Improvement
Authored by Savannah Badalich

Sponsored by Avi Oved, Maryssa Hall, CARE S.O.S., Clothesline Project at UCLA, Social Awareness Network for Activism through Art (SANAA), Bruin Feminists for Equality, and UCLA Student Worker Union (UAW Local 2865)

WHEREAS, 1 in 3 women and 1 in 6 men will be sexually assaulted over the course of their lifetime, and 19% of women will "experience attempted or completed sexual assault since entering college;" and,

WHEREAS, "Title IX is a landmark federal civil right that prohibits sex discrimination in educational institutions that receive federal funding. Sex discrimination includes sexual harassment and sexual violence since it creates a hostile educational environment;" and,

WHEREAS, the Clery Act is "a federal law that requires colleges to report crimes that occur 'on campus' and school safety policies...[the] Act also requires schools to have timely warning when there are known risks to public safety on campus and also contains the Campus Sexual Assault Victim's Bill of Rights, which requires colleges to disclose educational programming, campus disciplinary process, and victim rights regarding sexual violence complaints;" and,

WHEREAS, "the Campus Sexual Violence Elimination (SaVE) Act increases transparency on campus about incidents of sexual violence, guarantees victims enhanced rights, sets standards for disciplinary proceedings, and requires campus-wide prevention education programs. Under the Act, colleges must publish the victim's rights and college responsibilities." In addition, the Act "broadened Clery requirements to address all incidents of sexual violence (sexual assault, domestic violence, dating violence and stalking);" and,

WHEREAS, it is necessary to educate students about their Title IX rights, the Clery Act and the Campus SaVE Act, so survivors of sexual assault will be able to empower and advocate for themselves during their reporting process with either the UCLA Office of the Dean of Students, UCPD, or UCLA Title IX Coordinator.

WHEREAS, the total number of "sex offenses" in UCLA's 2012 Jeanne Clery Disclosure of Campus Security Policy, Campus Crime Statistics & Annual Fire Safety Report was 15, with 4 classified as "forcible rape," 1 classified as "sexual assault w/object," 1 classified as "forcible fondling," and 9 classified as "sex offense - not classified or unknown;" and,

WHEREAS, these numbers do not provide an accurate representation of the number of sexual assaults that occur on UCLA's campus as students do not report sexual assault for reasons such as for fear of public ostracization or humiliation, and/or legal action that they will not be able to impact, seeking support from UCLA campus-operated resources instead; and,

WHEREAS, visibility and availability of UCLA's campus-operated or affiliated sexual assault and prevention resources, such as the UCLA Counseling & Psychological Service (CAPS) Campus Assault Resources and Education (CARE) program and UCLA Santa Monica Rape Treatment Center, need to be improved; and,

WHEREAS, the UCLA Student Conduct Procedures for Allegations of Sexual Harassment, Sexual Misconduct, Domestic and Dating Violence, and Stalking defines "effective consent" as " words or actions that show a knowing and voluntary agreement to engage in a mutually agreed-upon sexual activity. Effective consent cannot be gained by force, by ignoring or acting in spite of the objections of another, or by taking advantage of the incapacitation of another, where the accused Student knows or reasonably should have known of such incapacitation. Effective consent is also absent when the activity in question exceeds the scope of Effective consent previously given;" and,

WHEREAS, the definition of "effective consent" in the UCLA Student Conduct Procedures for Allegations of Sexual Harassment, Sexual Misconduct, Domestic and Dating Violence, and Stalking is inadequate and needs to be elaborated upon.

THEREFORE BE IT RESOLVED that the Undergraduate Students Association Council urges the UCLA Office of the Dean of Students, the UCLA Title IX Coordinator, UCLA Campus Human Resources, UCLA Office of Residential Life, UCLA New Student & Transition Programs, and UCLA Graduate Division to publicly state how they will add to existing education programs promoting awareness of rape and acquaintance rape the topics of domestic violence, dating violence, sexual assault, and stalking.

LET IT BE FURTHER RESOLVED that the Undergraduate Students Association Council urges the UCLA Office of the Dean of Students, the UCLA Title IX Coordinator, UCLA Campus Human Resources, UCLA Office of Residential Life, UCLA New Student & Transition Programs, and UCLA Graduate Division to publicly state how they will include the definition of consent, options for bystander intervention, and risk reduction awareness information in education programs designated for incoming students and new employees in order to be in compliance with the Campus SaVE Act.

LET IT BE FURTHER RESOLVED that the Undergraduate Students Association Council urges UCLA to require a minimum of an hour of training, annually, on issues related to sexual violence and sensitivity training toward sexual assault survivors by UCLA CAPS CARE counselors for individuals conducting formal investigations of reports in order to be in compliance with the Campus SaVE Act.

LET IT BE FURTHER RESOLVED that the Undergraduate Students Association Council encourages Student Conduct Committee Chairs to go through additional training

regarding what questions addressed to both the complainant and accused are appropriate or inappropriate, as they are given the power to vet questions as stated in the UCLA Student Conduct Procedures for Allegations of Sexual Harassment, Sexual Misconduct, Domestic and Dating Violence, and Stalking.¹⁵

LET IT BE FURTHER RESOLVED that the Undergraduate Students Association Council believes the following additions to existing policies around sexual assault and harassment will strengthen the rights and resources for survivors, with the goal of ensuring the accused and the survivor are awarded equal rights and respect without infringing on the right of the accused to due process and the presumption of innocence until proof of guilt:

- 1. A UC-wide disciplinary process for former accused individuals who leave the University before their cases are resolved.
- 2. A clause stating the complainant will receive communication on all remedial and corrective action, including any disciplinary action.
- 3. An expansion of the duties of the UCLA Title IX Coordinator to include annual publication to the student body at-large of data related to the number of sexual assaults and sexual harassments reported to the office and the disciplinary action sought in each case.
- 4. A clause explicitly protecting students, including undocumented students, from police involvement against their will.
- 5. A clause explicitly giving the complainant the right to call for a formal investigation.
- 6. A Medical Amnesty and Good Samaritan policy to protect survivors of sexual assault and witnesses, respectively, from being punished for being under the influence of illegal substances.
- 7. An extensive social media and marketing campaign by the UCLA Title IX Coordinator to educate students on their Title IX, Clery Act, and Campus SaVE Act rights, as well as their sexual assault resources on campus, such as those found on the UCLA Sexual Harassment Prevention Office website.

LET IT BE FURTHER RESOLVED that the Undergraduate Students Association Council urges the UCLA Office of the Dean of Students to change the UCLA Student Conduct Procedures for Allegations of Sexual Harassment, Sexual Misconduct, Domestic and Dating Violence, and Stalking to include the following definition of consent, as drafted by UCLA students, to meet or exceed the changes to the University of California, Sexual Harassment & Sexual Violence Policy:

1. **Consent** is informed. Consent consists of an affirmative, unambiguous, and conscious decision by each participant to engage in mutually agreed-upon sexual activity.

Consent to some sexual acts does not imply consent to others, nor does past consent to a given act imply present or future consent. **Consent** must be ongoing throughout a sexual encounter and can be revoked at any time.

Although consent does not need to be verbal, verbal communication is the most reliable form of asking for and gauging consent, and you are thus urged to seek consent in verbal form. Presumptions based upon contextual factors (such as clothing, alcohol consumption, or dancing) are unwarranted, and should not be considered as evidence of consent.²⁰

- 2. **Consent** is voluntary. It is given without coercion, force, threats, or intimidation; it is a positive cooperation in the act or expression of intent to engage in the act pursuant to an exercise of free will.
- 3. **Consent** is given when the person is not impaired or incapacitated. A person cannot consent if s/he is unconscious or coming in and out of consciousness. A person cannot consent if s/he is under the threat of violence, bodily injury or other forms of coercion, or has a mental disorder, developmental disability, or physical disability that would impair his/her understanding of the act.
- (a) Incapacitation is the physical and/or mental inability to make informed, rational judgments. States of incapacitation include, but are not limited to, unconsciousness, sleep and blackouts.
- (b) Where alcohol or drugs are involved, incapacitation is distinct from drunkenness or intoxication, and is defined with respect to how the alcohol or other drugs consumed impacts a person's decision-making capacity, awareness of consequences, and ability to make fully informed judgments.

The factors to be considered include whether the accused knew, or a reasonable person in the position of the accused should have known, that the complainant was impaired or incapacitated.

LET IT BE FURTHER RESOLVED that the Undergraduate Students Association Council calls for increased permanent funding for UCLA Counseling & Psychological Services (CAPS) Campus Assault Resources and Education (CARE) program from the UCLA Student Fee Advisory Committee to increase the number of staff and expand its services and outreach.

LET IT BE FURTHER RESOLVED that the Undergraduate Students Association Council calls on the UC Office of the President (UCOP) to conduct a UC-wide evaluation on Title IX inconsistencies and present recommendations to improve resources and reporting procedures for survivors of sexual assault.

LET IT BE FURTHER RESOLVED that the USAC Student Wellness Commissioner will communicate these concerns and demands to the UCLA Title IX Coordinator, the UCLA Student Care Manager, and the UCLA Office of the Dean of Students.

LET IT BE FURTHER RESOLVED that the Undergraduate Students Association Council calls on the UCLA Title IX Coordinator, the UCLA Student Care Manager, and UCLA Office of the Dean of Students to make a plan of action to address the aforementioned concerns. Additionally, this plan of action should be made public via the Daily Bruin and/or a campus-wide email that is comprehensible and easy to understand

by students; updates and accomplishments should be provided to USAC and Daily Bruin at the end of each academic quarter.

LET IT BE FURTHER RESOLVED that the USAC President and USAC External Vice President will communicate these concerns and demands to UCOP Vice President of Student Affairs, UC President, UCOP Deputy to the Vice President, and the UC Students Association Board of Directors.

LET IT BE FINALLY RESOLVED that the Undergraduate Students Association Council advocates for a safer, more inclusive campus climate and encourages the improvement of resources for survivors of sexual assault.

- -Oved said Circle of 6 was included but before formally endorsing it they are speaking with the developers next Thursday and will provide a follow up. There is a lot to call to action.
- -Joanino opens up to comments to the revision.
- -Joanino states the term average student sounds a little weird.
- -Badalich stated that when she talked to the 9 network, they talk about it as the average student. -Joanino friendly amends to say students rather than average student.
- -Singh states that there was something about giving data, and is asking if its in compliance with privacy.
- -Badalich stated yes it's in compliance.
- -Hadjimanoukian asked what is defined as on campus.
- -Geller stated it includes university owned or managed properties, not just the campus limited to this space from Sunset to LeConte, it also is other things that are university owned and operated. It includes some public spaces if they are on the perimeter of campus and don't have to cross the street to get to there. She encourages everyone to talk to Nancy Greenstein.
- -Badalich states it does not include everything such as apartments.
- -Joanino asks if on campus includes university sponsored event would it count?
- -Geller stated no, it's a very specific legal definition and she really can't answer that, however folks from UCPD can do a better job.
- -Singh stated that SFAC would increase staff and services, and was wondering if she spoke to SFAC.
- -Badalich states yes, and has been talking to Grant and Joanino.
- -Joanino stated that it's good timing to discuss this right now and will consider things like that in the Spring. CARE is completely underneath CAPS which is why we would have to increase funding to CAPS specifically.
- -Joanino suggests that Badalich to share these with UCLA Title IX director and CAPS director
- -Hall was wondering where it says "promoting awareness and acquaintance rape" is there a distinction?
- -Badalich states that most risk reduction is stranger rape, but talking about acquaintance rape is close.
- -Ramalho is curious to know who she outreached to and if there was any problem with the language.
- -Badalich stated that the Student Worker Union loved it and went in and made corrections such as students to people and there were a few changes added and suggestions by

Clothesline. She outreached to anyone part of Facebook groups with all the classes and Bruin Alliance of Skeptics and the consent team, and Queer Alliance. Queer Alliance was not able to sponsor the bill because they didn't have time to meet. The sheer amount of places she sent it to, she received a good 20 edits. For example, the vague language was to incorporate the LGBT community.

- -Trumble requests to change his or her to their, to be gender neutral.
