AC Community Service Mini-Fund: Jonathan Wisner\*

- Openings: Five (5) positions, 1 Chairperson, 4 members (2 of the 4 must be affiliated with CPO, the other 2 with CSC), 1-year term, July through June
- Fieldman: The Community Service Mini Fund Committee is dedicated to providing funds for student community service programs, activities or services which contribute to the elimination of poverty and social problems, and/or provide services (such as health and education) to underserved groups. Holds five hearings per academic year.

Campus Programs Committee: Jennifer Tarango\*

- Openings: Four (4) positions (3 regular and 1 alternate), 1-year term, July through June
- Fieldman: The Campus Programs Committee is a subcommittee of the Programs Activities Board. CPC provides funds for student initiated, student-organized cultural and educational programs that take place at UCLA. The target audience for these programs should be UCLA. The exception to this are events that bring youth and/or community college students on campus for educational and outreach programs. These programs can apply to the CPC Youth Programming Fund for support. Solicits student views on the nature and goals of campus programming and holds hearings to allocate funds for campus programs. Must attend a four-hour Orientation in early August, participate in CPC's six hearings which are held throughout the academic year, beginning in September, and attend Quarterly meetings. In addition, must sit on CPC Mini-Fund Committee for one quarter and attend their weekly hearings which are held from Week 2 to Week 8. There is also a mandatory summer retreat. Time commitment: Approximately 20 hours per month.

#### Student Conduct Committee: Karen Funk#

- Up to 3-year term (3 years or graduation, whichever comes first)
- Fieldman: Provides hearings for all cases referred to it under the Student Conduct Code. Must attend an Orientation in early October. Meets when there is a case to be heard, including summer and breaks. 3 openings, non-stipended.

#### Campus Retention Committee: Roberto Vasquez#

#### Faour

- CRC oversees the funding evaluation of the student retention center in CPO which is a collective effort of students from historically underserved communities to help undergraduate students with academic difficulties and cultural and social positions focusing on retention. Responsibilities include attendance and participation at weekly CRC meetings in the evening and reporting to the Student Wellness Commissioner for updates.
- Non-stipended, weekly meetings
- Run health and wellness committee, report to Faour weekly
- Appointment has been working with CPO for all five years.

### VI. Special Presentations

CalFresh Initiative

Manzano

- CalFresh, also known as Supplemental Nutrition Assistance Program (SNAP) or colloquially known as food stamps is a federally funded program that helps with the cost of of buying groceries and prepared meals. Participants can get up to \$192/month for groceries with benefits preloaded into a debit card (EBT card) which is accepted in most grocery stores and farmers markets.
- The CalFresh Initiative at UCLA began in order to bring awareness and promote CalFresh (SNAP) as a resource to the thousands of college students that are eligible on our campus in order to fight food insecurity and support healthy eating habits
- Nearly half of those eligible for CalFresh (3.2 million) are not receiving it.
- 90024 CalFresh participation rate: 2%
- UC Students Food Insecurity Rate: 42%
- AB 1930: if a student has CalGrant A/B, automatically get CF
- AB 453: funding to designate for "hunger free campuses"
- UCOP funds each campus with \$151,000 for Basic Needs Efforts
- CalFresh eligibility: receive Calgrant A/B, accepted work-study, work 20+ hours, or have a child
- Verification documents: proof of financial aid, schedule of classes, ID card, social security number, rent/lease agreement, pay stubs.
- Summer hours: SAC CPO 105E 12-4pm
- Basic needs resources fair: calfresh enrollments
  - Partnered with Financial Aid to notify 4000 eligible undergraduates
  - Promoted via social media, counselors and campus partners
  - Asked various resource groups to table:
    - California Lifeline
    - Financial Wellness Peers
    - USAC EVP office SB900 phonebanking
    - SWC BruinNecessities
    - Department of Public Social Services Outreach Team
  - Intervention targeting 300+ students altogether at quarterly events

- Calfresh outreach projects
  - Plan an enrollment day 1-2 months before
  - Send an Outreach Participation Request to DPSS
  - After confirmation set up a room with Graduate Student Resource Center
    - SAC Conference Room 4 10am-4pm
    - Weekly CalFresh meetings
  - Set up a mass financial aid email with Edward Conroy econroy@saonet.ucla.edu
  - Set up mass emails with counselors/listserv to promote the enrollment day
  - Promote on social media Facebook free and for sale, free food at ucla, set up an event
  - Set up volunteers and parking permits for the day of come early on the day

## X.. New Business

Discussion Item: Prop 10 Resolution

WHEREAS: Proposition 10 would repeal the Costa-Hawkins Rental Housing Act, which prevents municipalities from enacting rent control on properties built after 1995, allows landlords to raise rent to market levels after a tenant moves out of a rent-controlled unit and forbids rent control from being applied to single-family homes and condos. Whereas Costa Hawkins prohibits limitations on annual rent increases causing neighborhoods with 'hot housing markets' such as neighborhoods surrounding universities to face extreme rent hikes. Whereas, Westwood has the most expensive apartment rental rates in the city of Los Angeles, with the average price of a two-bed apartment soaring to nearly \$4,200. Whereas, the city of Los Angeles declared a "state of emergency" on homelessness in September 2015 and homelessness rates in the Westwood area increased by 22-27% from 2016 to 2017. Whereas Students, Seniors, Latinos, African-Americans, low-wage workers, and families with young children are the most affected by

California's Housing crisis. Whereas Five percent of both UC undergraduate and graduate student populations said they had experienced homelessness at some point during their enrollment,

- Let it be resolved that the 2018-19 USAC supports California Proposition 10 to help combat student housing insecurity. Let it further be resolved that USAC urges the UCLA administration, including but not limited to Chancellor Block, make a statement supporting this legislation.
