IX. New Business

Discussion Item: HR Documents

Shaw

- Lily: I've had a really hard time stipending my directors because a lot of them are out of state or international and don't have all of the documents necessary for HR and they have to be original copies. For everyone to get all of their documents its going to take a really long time, and they don't get paid until they get those documents. I don't think we have any jurisdiction over it, I just wanted to voice a complaint.

Discussion Item: Elevators

- Lily: The Kirchoff elevator has broken 4 times in the last week. When this happens I can't get to my office or get out of my office to get to class. The Kirchoff elevator permit expired May 2018. That's the only way to get up to my office. I was stuck in my office for an hour and couldn't get to class. The same thing is happening in Bunche. The elevators in Bunche stop running at 7pm. I had to wait 30 minutes for someone to come open it. This is most likely happening to a lot of students that have mobility issues.
- Johanna: Aiden from ASUCLA/BOD is really passionate about deferred maintenance and is working 24/7 to make sure the university has enough funds to fix our elevator. I can follow up on this because I believe the governor gave us substantial money this year to put that in but I'm not sure when it will go into effect.
- Johnathan: Last year I went to a town hall where this issue of expired elevator permits was brought up. Essentially what I was told was that there is a ridiculously low number, it's something like two or three, for the entire region of Southern California of people that can recertify elevators. So most elevators will be out of date for something like 5 years because there's only like two people to service the thousands of elevators and millions of people.
- Shahamah: I was told the same thing, that the LA system itself is what is delaying it. But that does not justify it.
- Robert: We should definitely follow up on this for the upcoming council.

Discussion Item: Financial Accountability

- Robert: I had brought up in my meeting with Vice Chancellor Gordon and Chancellor Block about wanting committees that derive their funding authority from the Undergraduate Students Association to be more transparent with their funds and accountable to their funding. Vice Chancellor Gordon suggested we send in some sort of list or request as far as what we're looking for, as far as like do we want the budgets of these meetings, the minutes, both? They were requesting that we send in a list or something that asks for this.
- Johanna: do you know how many years we're requesting this for? How many years back?
- Robert: The way that I framed it was asking for this year specifically.
- Naomi: It's standard practice that you should be releasing your meeting minutes, you should be releasing your budgets.
 That's public information. Students have the right to see where their fees are going. Just like everyone else, you should have to post your meeting minutes and your budgets.
- Robert: As USAC, we are accountable for where the student fees are going. Most of our referenda are not transparent about where that money is being used. There should be some degree of transparency. Especially when students are saying they don't know where the money is or where it's going. I would like to act on this while we're still on council.
- Johanna: I want budget reports from the last 3-5 years and I want meeting minutes from last year.
- Kim: So I have SS, CRC, SAC, Basic Needs, and John Wooden.
- Robert: I can write the letter but I'm going to do it Week 6. I think a deadline of Week 6 or 7 is good.
- Johanna: Just to clarify, we wanted 3-5 years of budgets and 1 year of minutes.
- Kim: So the committees we want to reach out to: SFC, CRC, John Wooden Center, Basic Needs. This would be due week 6 or 7. What we want is 3-5 years back of budgets and financial transactions then moving forward, a year of

minutes and moving forward, publicly advertise their meeting dates and times and if we want more info we will continue to request it.
