The Election Board shall consist of an Executive Committee and five Subcommittees: Investigations, Publicity, External Relations, Endorsements, and Finance. The terms of all positions expire at the end of the Spring Quarter.

The Election Board shall consist of an Executive Committee and may consist of five Subcommittees: Investigations, Publicity, External Relations, Endorsements, and Finance. The terms of all positions expire at the end of the Spring Quarter.

The Election Board Chair shall have the discretion to decide the number and composition of committees under their purview.

2.3.1

The Election Board Chair shall be appointed in the Fall Quarter or summer if a special election is to occur in the Fall Quarter, by the Undergraduate Students Association President and must be approved by the Undergraduate Students Association Council, herein referred to as the USAC. The appointment shall be made through an impartial selection of applicants solicited in the Spring or Summer Quarters through the Daily Bruin. The Election Board Chair will remain in office until their resignation or removal, or until the completion of the Spring Quarter.

The Election Board Chair shall be appointed in the Fall Quarter or summer if a special election is to occur in the Fall Quarter, by the Undergraduate Students Association President and must be approved by the Undergraduate Students Association Council, herein referred to as the USAC. The appointment shall be made through an impartial selection of applicants solicited in the Spring or Summer Quarters through the Daily Bruin. The Election Board Chair will remain in office until their resignation or removal, or until the completion of the Spring Quarter.

2.3.4

During the Fall Quarter, or summer if a special election is to occur in the Fall Quarter, the Election Board Chair shall appoint Subcommittee Directors who must be approved by the USAC. These members shall serve until their resignation or removal, or until the completion of the Spring Quarter.

During the Fall Quarter, or summer if a special election is to occur in the Fall Quarter, the Election Board Chair shall appoint Subcommittee Directors who must be approved by the USAC. These members shall serve until their resignation or removal, the dissolution of Election Board, or until the completion of the Spring Quarter.

In the event of the resignation or removal of the Election Board Chair and the Election Board Vice Chair, the current Election Board will be dissolved and a new Election Board Chair shall be appointed by USAC for the remainder of the unexpired term.

- Q. Submit to the university appointed administrative advisor the correct log-in information (usernames and passwords) to all official election board social media and email accounts.
 - i. Log-in information to all official election board social media and email accounts must be submitted no later than 1 week after the results of the Spring election have been announced. If the election board chair is removed or resigns, they must submit log-in information to all official election board social media and email accounts within one week of their removal or resignation.
 - Ii. Failure to submit all official election board social media and email accounts by the appropriate deadline described in provision 2.4.1q may result in the university appointed administrative advisor to (at their discretion) request a hold on the outgoing or removed Election Board Chair's university account.

iii. Provision 2.4.1q will in no way will preclude the Election Board Chair to change the log-in information to all relevant and official election board social media and email accounts, and/or withhold log-in information from the university appointed administrative advisor, until the appropriate deadline as described in provision 2.4.1.q.i

Iv. Provision 2.4.1q will in no way will preclude a Election Board Chair to create a new social media account, given that the account is created on a platform that does not have an existing and accessible Election Board account.

V. The Election Board may not create any new email accounts for any correspondence regarding elections.

Members of the Executive Committee, Vice Chair, and the Chair will be responsible for hosting Office Hours during normal business days. These office hours must be posted on the Election Board Bulletin Board and on the official Election Board social media pages and should be held through the final election.

The Election Board must respond to any digital inquiries via the official Election Board email from currently enrolled UCLA students within 24 hours for emails received on official school days. During 0 week, and on non-school days, the Election Board may take up to 48 hours to respond to any digital inquiries. During finals week and official breaks, the Election Board does not have to respond to any digital inquiries until the first school day of the following quarter.

Proposal by USAC Approval: Amendments may be proposed to the Association for ratification following their approval by two-thirds (2/3) of the 12 voting members of the USAC.

3.6.3

Notice of the election and a complete statement of the proposed Constitutional Amendment shall be published on the Election Board's USAC webpage and the Election Board's official social media accounts at least one week prior to the election.

3.7.1.b

An advisory vote is any poll of the Association placed on an election ballot by a two-thirds (2/3) vote of the USAC, or by presentation to the USAC and/or Election Board by any member of the Association in the form of a petition bearing the signatures of 5% 10% of the members of the Association.

5.1.4a

For the election of the Executive and Commissioner positions, which includes the President, the Internal Vice-President, the External Vice President, the Academic Affairs Commissioner, the Campus Events Commissioner, the Community Service Commissioner, the Student Wellness Commissioner, and the Cultural Affairs Commissioner, the Financial Supports Commissioner, the Facilities Commissioner and Transfer Student Representative the Instant Run- off Vote system shall be used.

A portion of this meeting shall be dedicated to the detailed explanation of authorized and unauthorized campaigning procedures under the current election code. in the Residence Halls by a Residential Life Representative and/or the External Relations Committee Chair.

Voting shall be by online via My.UCLA.

If the technological resources are not available to carry out elections online or an emergency situation exists, then a paper ballot system will be used as delineated by the following:

If the technological resources are not available to carry out elections online, an emergency situation exists, or the Election Board wishes to use supplemental polling stations pursuant to provision 6.1.1, then a paper ballot system will be used as delineated by the following:

6.1.3a

All students, to be eligible to vote, must present their UCLA Student Identification Card to the poll worker who will slide the card though the "Bruin Card" scanner. The poll worker must be satisfied that the picture on the UCLA Student Identification Card matches the student. In order to receive a ballot, the voter must sign the Voter Registration List, and include their Registration number. The voter shall then be handed one (1) ballot.

- a. All students, to be eligible to vote in a physical polling location using a paper ballot, must present their UCLA Student Identification Card to the poll worker who will slide the card though the "Bruin Card" scanner. The poll worker must be satisfied that the picture on the UCLA Student Identification Card matches the student. In order to receive a paper ballot, the voter must sign the Voter Registration List, and include their Registration number. The voter shall then be handed one (1) ballot.
- b. All students, to be eligible to vote in a physical polling location using a digital ballot need only to present their UCLA Student Identification Card to the poll worker. The poll worker must be satisfied that the picture on the UCLA Student Identification Card matches the student; the student also has the option to log-in to their UCLA account and show the poll worker their class schedule for the quarter of the scheduled election.

6.1.3b

The Election Board Chair shall determine the number and location of polling stations with the USAC approval. A list of polling stations will be provided to all undergraduate students. Polling stations shall be open during the hours designated by the Election Board Chair with the USAC approval.

If an emergency situation threatens the security of any polling stations or students, the Election Board Chair, in consultation with the University appointed Administrative Advisor, may order the closing of any or all polling stations. If polling stations are closed because of an emergency situation, the Election Board Chair shall determine if there is sufficient cause to warrant additional time for balloting. The additional time for balloting shall be no greater than the amount of time that the polling stations were closed. If so, the Election Board Chair shall notify the Undergraduate Students Association President and the University appointed Administrative Advisor. The Election Board Chair shall designate the date(s), times, and polling locations with the USAC approval, and inform students of the decision.

If an emergency situation threatens the security of any polling stations or students, the Election Board Chair, in consultation with the University appointed Administrative Advisor, may order the closing of any or all polling stations. If polling stations are closed because of an emergency situation, the Election Board Chair shall determine if there is sufficient cause to warrant additional time for balloting. The additional time for balloting shall be no greater than the amount of time that the polling stations were closed. If so, the Election Board Chair shall notify the Undergraduate Students Association President and the University appointed Administrative Advisor. The Election Board Chair shall designate the date(s), times, and polling locations with the USAC approval, and inform students of the decision. This provision shall not apply in the instance that the Election Board wishes to use supplemental polling stations pursuant to provision 6.1.1

6.1.3d

If a polling station has been closed or moved (e.g., due to rain), a sign shall be posted at the original location stating where other open polling stations are located.

If a polling station has been closed or moved (e.g., due to rain), a sign shall be posted at the original location stating where other open polling stations are located. Physical polling stations that are intended to be a supplement, pursuant to 6.1.1, can be closed at the discretion of the Election Board Chair without a replacement location.

6.2.3

Following the conclusion of an election, an uneditable digital file containing the results of each casted ballot must be uploaded onto the official Election Board website and retained by the university-appointed administrative representative to the Election Board for three months following an election in the instance that retabulation of the votes is necessary.

8.2.2b.iv.5

Student Organization Signboards that do not comply with Center for Student Programming standards may not be used

Student Organization Signboards that do not comply with Student Organizations Leadership and Engagement (SOLE) standards may not be used.

8.2.2.b.v.2

All physical campaign material and campaign literature must be approved by the Election Board prior to its public distribution and abide by University policies. All digital campaign material and campaign literature must be approved by the Election Board

prior to its public distribution and abide by University policies. The Election Board shall have 48 hours to review all campaign materials and notify candidates if they are approved. During 0 week, 10th week, the Election Board may take up to 72 hours to approve campaign literature. During finals week and during official breaks, the Election Board does not have to approve campaign literature until the first school day of the following quarter. The Election Board may only withhold approval of campaign materials and/or campaign literature if such materials are libelous, contain false information, or pose a significant threat to campus climate or safety.

8.2.2.b.v.4

All physical campaign materials being publicly distributed, All stampable campaign material, with the exception of endorsement slips, shall contain the current Election Board stamp or logo. Time constraint does not constitute a valid exception to exclusion of the Election Board logo. Any exception to this aforementioned provision shall be approved in the manner provided for by the subsequent section. The placement of the Election Board stamp or logo must be prominent and conspicuous. The stamp or logo shall be no smaller than one percent (1%) of the printed area.

8.2.2.b.v.5

For all physical campaign materials being publicly distributed, approval of non-stampable campaign material may not be denied due to the inability to affix the Election Board logo to said material. If it is impossible or infeasible to affix the logo, the election board shall keep on file a photograph and description of the object. The Election Board shall make public a list of all approved campaign material.

8.2.2.b.v.7.d

For all physical campaign materials being publicly distributed, the placement of the Election Board stamp or logo must be prominent and conspicuous. The stamp or logo shall be no smaller than one percent (1%) of the printed area of campaign material falls under a different category, it shall not be considered to be campaign paraphernalia.

8.3.a

Campaign material of any sort shall not be attached to vegetation, any campus building, wall, permanent or temporary fixture (including construction walls and 32 fences), and/or campus event bulletin boards. This shall not be construed to preclude the posting of Residence Hall posters or the posting of campaign literature by the resident on the door of their respective room.

8.3.f.i

Within structural or physical confines of buildings. This shall not be construed to preclude the posting of Resident Hall Posters, or the posting of campaign literature by the resident on the door of their respective room."

8.3.f.vi

vi. Within Residence Halls, except as provided in specific regulations governing distribution in Residence Halls.

8.4 (entire): Campaigning in Residential Areas

- Lalo motions to extend time for 30 min at 9pm, 10-3-0 motion passes

A. In addition to the provisions of this Election Code, campaigning in UCLA On Campus Housing shall be governed by the regulations, definitions, and protocol outlined in the UCLA On Campus Housing Student Handbook. Any violation of the UCLA On Campus Housing Student Handbook will also be considered a violation of this Election Code.

i. The Residence Halls will be defined as all areas governed by the Residential Life Office west of Charles E. Young Drive.

ii. In the UCLA On Campus Housing Handbook, tThe term "campaigning" is

defined as any display on the part of any person for the purpose of convincing other people to vote for or against a candidate, initiative, referendum, constitutional amendment or recall. (Note: this will go under the clause A proposed in Slide 45)

iii. Posting of campaign material is limited to the following stipulations:

- 1. Residents may post campaign material on the door of their perspective room.
- 2. In order to post campaign materials Designated Campaign Representatives will be allowed one (1) of the following:

a. 14 posters no larger than 22" by 24" or b. 47 posters no larger than 11" by 17"

- 3. These posters must be submitted to the Residential Life Central Office. If approved, they will be distributed throughout public areas as seen fit by the Residential Life. All Designated Campaign Representatives will have equal access to posting in the Residence Halls.
- iv. There will be NO campaigning on the individual floors including door-to door campaigning, in person, or with printed material.
- v. Campaigning in the dining facilities is prohibited.
- vi. Use of mailboxes is permitted only through the regular U.S. Mail's postage and distribution process. The public address system may not be used for campaigning of any sort.
- vii. All posters must be removed and discarded within 24 hours after the election.
- viii. Distribution of campaign material of any kind is prohibited with the exception of the posting allowances.
- ix. Campaigning is prohibited on any University owned or managed living facility including but not limited to, University Apartments, Residence Halls, etc.
- A. Campaigning is prohibited in all areas governed by the UCLA Office of Residential Life west of Charles E. Young Drive, including but not limited to, University Apartments, Residence Halls, and any associated facilities.
 - i. The term "campaigning" is defined as any display on the part of any person for the purpose of convincing other people to vote for or against a candidate, initiative, referendum, constitutional amendment or recall.
- B. Provision 8.4.A shall not preclude campaigns from conducting invitation-only meetings in a residence hall room, a self-reservable space, or university apartment, given that permission is obtained from all residents in a shared space.

8.6: Rename Technological and Social Media Guidelines

- Eliminate entire section.
- The Election Board Chair shall establish a set of Social Media Guidelines by Week 7 of the quarter preceding an election. These guidelines must be approved by the USAC and publicly published on the official Election Board social media pages and the official USAC Elections website. They cannot be changed following the start of a quarter during which an election is set to occur until the election's conclusion.

8.7.c.i

Placing any campaign literature on university property within the grounds of a university managed living facility. This shall include, but not be limited to, indoor and outdoor walls, waste receptacles, trees, public bulletin boards, and any other residential space. This item shall not prohibit the storage of materials posting of literature inside rooms without public display,; including on windows, or on personal bulletin boards, provided in either case that the permission of the affected resident is obtained.

9.1.1a

Candidates for all offices will be allowed to spend up to \$450 on their campaigns.

Candidates for all offices will be allowed to spend up to \$500 on their campaigns.

9.1.3.

The deadline for turning in the Spring Quarter election expense account forms shall be at a time no more than one (1) week before the voting week which will be determined by the Election Board. The deadline for turning in Special election expense

account forms shall be at a time no more than one (1) week before the voting week which will be determined by the Election Board and approved by the USAC. Failure to turn in expense account forms that are complete, accurate, and on time may result in penalties in accordance to the Infractions & Penalties Guideline and as determined by the Election Board Chair.

9.1.1

10.1.1.a

a. All organizations are required to register with the Election Board at most three (3) weeks prior to the Election, at a time to be designated by the Election Board. Any and all groups failing to meet this deadline will not be allowed to post endorsements.

Only the university-recognized representatives (i.e. signatories) of registered student organizations are allowed to register their group with the Election Board to participate in the group endorsement process.

Only the university-recognized representatives (i.e. signatories) of registered student organizations are allowed to represent their group in the endorsement process.

10.1.1.c

All university-recognized representatives of registered student organizations shall be notified, by an e-mail from the Election Board, concerning the date and time of the Endorsement Orientation Meeting, at which the endorsement procedures and relevant deadlines will be delineated. University-recognized representatives are responsible for any and all communication with the Election Board throughout the election process.

Representatives also have the option of participating in the Election Board hosted Debate or a Meet the Candidates event, as a substitute for attendance at the Endorsements Hearing.

Any Designated Campaign Representative attending unrecognized endorsement forums shall be sanctioned. The organization holding the endorsement hearing shall also be sanctioned.

ASUCLA Communications Board media entities, although not UCLA registered student organizations, may request to participate in the endorsement process but are not required to do so in order to endorse."

Format of the debate will include equal time allotments for speaking for candidates of a particular office. Times may differ between offices. Candidates and Designated Campaign Representative will be informed of debate procedures no later than three (3) school days after the Candidate Orientation Meeting. Detention, Surveillance and Repression of the Uyghurs and in Condemnation of China

WHEREAS, China has forcibly detained 1-3 million¹ Uyghurs and other predominantly Muslim Turkic peoples in a large network of concentration camps since 2017,² the largest mass internment of an ethnic-religious minority since World War II³;

WHEREAS, satellite evidence⁴ and two sets of independently-verified files from the Chinese government leaked in November of 2019⁵ 6 confirm the existence of this extensive network of

including torture, rape, foced abortions, and medical experiementation,¹¹ ¹² ¹³ while also being subjected to political indoctrination with the aim of eradicating their Uyghur and Turkic Muslim religious identity and culture¹⁴;

WHEREAS, detainees held in these camps are systematically used as forced labor at factories that export internationally and which have ties with US corporations ¹⁵ ¹⁶ ¹⁷;

WHEREAS, China currently deploys one of the world's most sophisticated surveillance and monitoring operations against the Uyghurs and other Turkic Muslims living in Xinjiang, including the use of advanced facial recognition technology, maintaining of a DNA and biometric data catalog on the Uyghur population, regulating Uyghur life with tens of thousands of checkpoints, monitoring Uyghur digital communications, and placing of hundreds of thousands of state-sponsored Han Chinese men to live in the homes of Uyghur families in order to monitor their behavior¹⁹;

WHEREAS, approximately half a million Uyghur children have been forcibly separated from their families and placed in a mass network of state-run boarding schools where they are subjected to state indoctrination meant to eradicate their beliefs and identity²⁰;

WHEREAS, China's purging of Uyghur cultural and religious identity has included the secret

destruction of historic Uyghur mosques²¹ and burial grounds²², along with the targeting of Uyghur academics and intellectuals in its mass detention program²³;

WHEREAS, China has targeted Uyghurs and Chinese activists living abroad with fear of retaliation for speaking out against the crisis in Xinjiang, including on university campuses²⁴;

WHEREAS, on October 7th, 2019, the United States Department of Commerce blacklisted 28 Chinese entities over their surveillance and involvement in the repression of Uyghurs and other Muslim minorities in Xinjiang, including Hikvision, Dahua Technology, Megvii, Sensetime, Yitu Technologies, and the Xinjiang Production and Construction Corps (XPCC) Public Security Bureau²⁵;

WHEREAS, on October 8th, 2019, the United States Department of State formally condemned China for "institut[ing] a highly repressive campaign against Uighurs, ethnic Kazakhs, Kyrgyz, and other members of Muslim minority groups in the Xinjiang Uighur Autonomous Region (Xinjiang) that includes mass detentions in internment camps; pervasive, high-tech surveillance; draconian controls on expressions of cultural and religious identities; and coercion of individuals

to return from abroad to an often perilous fate in China," imposing visa restrictions on Chinese government officials believed to be responsibile or complicit²⁶;

WHEREAS, the United States Senate unanimously passed the Uyghur Human Rights Policy Act of 2019 (S.178) on September 11th, 2019, and the United States House of Representatives near-unanimously passed it (407 yeas and 1 nay) on December 3rd, 2019, condemning China on its repression of Turkic Muslims in Xinjiang²⁷;

WHEREAS, on November 16th, 2019, the UCLA Center for Near Eastern Studies, and the Department of Islamic Studies co-sponsored an academic panel on the Uyghur crisis, ²⁸ in which divestment from corporations complicit in China's repression of the Uyghurs, along with a review of academic collaborations made with complicit companies were suggested as recommended university-level responses to the humanitarian crisis²⁹;

WHEREAS, on September 22nd, 2014, the University of California became a signatory of the United Nations-supported Principles for Responsible Investment, which includes a commitment to incorporating environmental, social and governance (ESG) issues in investment decisions, along with seeking disclosure on ESG issues from entities in which the UC system invests³⁰;

WHEREAS, the Office of the Chief Investment Officer of the Regents has identified one of the primary ESG risks that guide its investment decisions as human rights concerns and "[b]usinesses whose profits are derived from direct harm to public safety, the unlawful

deprivation of human dignity, or the exploitation of children"31;

WHEREAS, the University of California, through its General Endowment Pool (GEP)³² and UC Retirement Plan (UCRP)³³, invests via direct holdings or externally managed funds and indices in companies complicit in China's repression of the Uyghurs, including Hikvision,³⁴ Dahua,³⁵ Qualcomm,³⁶ Yitu,³⁷ Western Digital,³⁸ Seagate,³⁹ Hunt's (Conagra Brands),⁴⁰ Ambarella Inc.,⁴¹

WHEREAS, UCLA has contracts with Thermofisher,⁴³ whose genetic sequencing technology was used in China's DNA database of the Uyghur population, and has had research collaboratives with and received financial gifts from the Hikvision Research Institute⁴⁴;

WHEREAS, the UCLA Store, run by ASUCLA, sells products from Western Digital,⁴⁵ in addition to several clothing lines with potentially suspect supply chains leading to Xinjiang, where over 80% of China's cotton is produced and where the government utilizes forced labor

from camp detainees to expand its textile industry⁴⁶,

THEREFORE LET IT BE RESOLVED, that the Undergraduate Students Association Council of the University of California, Los Angeles (USAC) will take a stand on one of the greatest human rights tragedies of the 21st century, by condemnning the government of China for its mass-detention, surveillance, and repression of the Uyghurs and other Turkic Muslim minority groups in Xinjiang;

LET IT FURTHER BE RESOLVED, that USAC rejects all forms of intimidation lodged by China against Uyghurs and others engaged in peaceful protest and activism abroad;

LET IT FURTHER BE RESOLVED, that USAC will do its part in raising attention to this crisis in and outside of the UCLA campus;

LET IT FURTHER BE RESOLVED, that USAC calls upon the University of California to investigate its direct holdings, externally managed funds, and all its financial instruments for investments in the companies complicit in the repression of the Uyghurs and procurement of benefit from their forced labor, including those outlined above, and others as they may come to light;

LET IT FURTHER BE RESOLVED, that USAC calls upon the University of California to divest and withdraw investments from these companies in accordance with its fiduciary duty, until these companies are no longer engaged in violating human rights as upheld in the UC-endorsed Principles of Responsible Investment, and to demand the same from its externally-managed funds;

LET IT FURTHER BE RESOLVED, that USAC calls upon UCLA to investigate its financial

contracts, investments, and research collaborations, and divest and disassociate from all entities complicit in China's repression of the Uyghurs, or whose supply chains benefit from their forced labor;

LET IT FURTHER BE RESOLVED, that USAC calls upon ASUCLA to investigate its financial contracts and divest from all entities complicit in China's repression of the Uyghurs, or whose supply chains benefit from their forced labor;

LET IT FURTHER BE RESOLVED, that USAC will submit copies of this resolution to the local Chinese consulate, in addition to the known investor relations offices of all the above-noted companies and externally-managed funds in the University of California GEP and UCRP;

LET IT FURTHER BE RESOLVED, that USAC calls upon the Assistant Vice Chancellor for Campus Life Mick Deluca, Vice Chancellor for Student Affairs Monroe Gorden, Dean of Students Maria Blandizzi, UC Chancellor Gene Block, all USAC Offices, and all GSA Offices to make a public statement of support or resolution in response to this statement.
