AVC Beck: Facial Recognition Policy Ban and Coronavirus Updates

Bonifacio

Kim: I wanted to invite you out tonight so we could open it up to council members if they had any questions about the facial recognition ban that was announced about a week ago as well as updates on the coronavirus. I specifically wanted to ask how the Coronavirus update will affect study abroad. I know that some schools have actually been considering stopping certain programs.

Beck: Thank you for the opportunity to come answer some of your questions. In regards to the facial recognition technology developed in the fall, we've been here a couple times to talk about that. We developed a security camera policy to create guidance in association with the use of the security cameras on campus. In that process the policy did not consider facial recognition technology which means it didn't prohibit it. So we decided to come back and look at were there limitations with the facial recognition technology that would make sense so that if utilized in the future certain things would be limited. [indiscernible] We shared that here and there was a forum with students, it went to the academic senate, there seems like a fair amount of anxiety about using facial recognition on campus.[indiscernible] we implemented a policy to actually prohibit it. So that policy will be updated, it will be circulated, and implemented.

Beck: So the Coronavirus. The current programs in which travel is restricted, except for essential travel, those programs are being closed. There is some consideration about whether any education abroad program would be appropriate for the spring quarter and those decisions are being considered by the office of the president and education abroad programs. We have about 150 students that will be participating in education abroad next quarter. So if those programs are closed we are looking at about how we can incorporate them into other courses for the spring quarter.

The undersigned Mother Organizations, student organizations, entities, and individuals demand that the administration of the Community Programs Office (CPO) comply with the requests made by the Undergraduate Students Association Council (USAC) on November 19, 2019, to present the past 3 years of budget reports to the undergraduate student body of UCLA. We are extremely concerned with the disbursement of the Campus Retention Committee (CRC) and Student Initiated Outreach Committee (SIOC) funds, considering these funds are comprised of student fees collected in accordance with the Social Justice Referendum, PLEDGE Referendum, PULSE Referendum, CARE Referendum, Academic Success Referendum, and the Service Referendum. <sup>1</sup>

The CRC and SIOC Administrative Representatives, and therefore the CPO, have allowed for the continuous violation of the Statement of Understandings (SOU) between USAC, Student Affairs, and the <sup>2</sup> Committees. The SOUs for the SIOC and CRC state that an annual budget report must be presented to USAC, something that has not been done in years. Similarly, both committees are to maintain full <sup>3</sup> authority and jurisdiction over all the Funds for Student Initiated Outreach (FSIO) and the Special Education Membership Fees (SEMF), both of which are allocated to the SIOC and CRC, respectively. <sup>4</sup> However, CPO administration has limited the autonomy of committee members in both the handling and decision-making regarding the distribution of these funds by providing committee members with budget limits and have negated any further conversation on line-item requests due to these imposed budget restraints.

Additionally, CPO's administrative staff have withheld budget reports despite persistent demands from committee members and their respective chairs. They have repeatedly claimed that the presentation of these budgets are not of the utmost priority. This claim is paradoxical given that the committees are granted the authority over the allocation of these funds and subsequently reserve the right to demand such

requests from an administrative entity that is meant to act as University support. The blatant disregard of <sup>5</sup> the committees' demands contradicts the fundamental notion that these committees are to be student-run and student-initiated. It is clear that the undergraduate students who comprise the SIOC and CRC are not to blame but, rather, the CPO administration, who has continuously worked to strip students of their mandated right, is.

The CPO was originally established by Students of Color with the purpose of supporting students from underrepresented and marginalized communities, while fostering a safe and positive environment. Students have witnessed and experienced CPO's deviation from their original purpose of serving students. In recent years, tensions between the Mother Organizations and the CPO administration has increased due to mismanagement and the continuous suppression of student voices, a glaring contradiction to their original purpose. This issue has seeped into the SIOC and CRC, resulting in decreased student control over student-led initiatives. Students have dealt with unjustified late or absent notices for meetings initiated by the CPO, have been threatened with the removal of personal electronic devices, threatened with dismissal during meetings, labeled 'racists' for disagreeing with administration, and have been overworked. The lack of transparency and accountability, hyper-surveillance, micro- and macro-aggressions, have made the Community Programs Office a toxic and unwelcoming environment for Students of Color at UCLA.

We are deeply saddened and concerned that the struggles of our predecessors are minimized and disregarded by the

administration of CPO and select voices have been strategically excluded from decision-making within CPO. We demand full transparency and accountability to Students of Color and other marginalized students of UCLA from the administration of CPO by fulfilling the following:

 Immediately presenting and publicizing the entire budget of the SIOC and CRC for the 2017-2018, 2018-2019, and 2019-2020 academic years by March 9, 2020 at 12 PM, which includes the following:

a. Full allocation CRC and SIOC receive b. CRC and SIOC committee allocation c. Memos d. All expenditures e. All unused funds returned to the CRC and SIOC <sup>6</sup>2. Posting meeting minutes and agendas to the CPO website for all Student Initiated Outreach

Committee and Campus Retention Committee meetings 5 days prior to meetings. 3. Revisit the SIOC and CRC SOUs with the USAC, the Mother Organizations representatives, the

Office of Student Affairs, and SIOC and CRC committee members to ensure that moving forward, all entities are being held accountable to what is mandated within these documents.

If anyone within CPO administration refuses to comply with these demands, we demand that they resign from their position effective immediately. We will no longer tolerate the everpresent dismissal of our

concerns and any form of retaliation that may be imposed on the projects housed under the SIOC and CRC. We will, however, continue to carry on our long legacy of advocacy and social justice on this campus, and will not allow this to interrupt our progressive movement towards the full liberation of our communities.

Good Clothes Good People: Sustainability Meets Accessibility

#### Who We Are

Good Clothes Good People (GCGP) is an avenue for the community to give back to the community. We operate at the intersection of sustainability and accessibility, and we offer clothing, hygiene products, and school supplies free for all students to pick up in our center at SAC B54. We also offer formal clothes, wheelchairs, and crutches for students to borrow.

#### How We Started

GCGP was started by Robert Watson in June 2017, in Louisville, KY as a way to take in clothing donations and redistribute them across the city.

#### How We Do It

Our bins are spread throughout campus and allow for students to donate items - typically clothing - and if it meets our standards, we offer it free for pickup in our center.

#### **UCLA Chapter!**

The founder brought GCGP back to UCLA with him, and through his role as USAC Internal Vice President, was able to start the UCLA branch, along with Director Jimmy Zhou. The branch opened its doors in SAC B54 in November 2018.

#### Accessibility

Our main focus when we started was accessibility. We wanted to make as many everyday items such as clothes, school supplies, and hygiene products more easily accessible to students in need.

#### Sustainability

- #1 No poverty
  - We make our products accessible to all students
- #2 Zero hunger
  - o Paying for everyday items such as clothes, school supplies, or hygiene products could mean skipping meals
- #3 Good health and well-being
  - Our products can help ensure good health and well-being so that students can focus on being students
- #4 Quality education
  - We want students to access the essentials, such as notebooks, that help them get a quality education
- #10 Reduced inequalities
  - We want to help even the playing field by giving everyone access to the same items
- #12 Responsible consumption
  - Almost all of our products are recycled or organic to ensure responsible consumption

## 2018-19 Funding

The Green Initiative Fund granted us \$10,000 to help us set up our center and provide students with everyday items.

USAC Surplus also granted us an additional \$8,000 to reward our volunteers and to continue center operations

#### Student Impact

- Between November 2018 and June 2019, we had close to 1500 (1476) students check out, and 40 students rent formal clothing from our center.
- Since September 2019, we have had 1436 students pick up items, and have rented formal clothing to 58 students, and have had 18 students borrow wheelchairs or crutches from our center as of 3/3.

#### Why a Referendum?

We want steady, nonexclusive funding

- We want to save students money
- We want to grow

## Referendum

Shall the USAC institute a new fee of \$0.33 per student per quarter to fund school supplies and hygiene products that are available for free to all students at USAC's Good People Good Clothes redistribution center, beginning in fall 2020?

This fee would be collected from all undergraduate students enrolled in Fall, Winter, and Spring. During summer quarter, the fee would be \$0.

The fee will be increased annually thereafter by the amount of the L.A. County CPI, if any. 25% of the amount collected will be returned to aid.

## Where would the money go?

- \$0.33 quarterly fee for each student
  - $\circ$  25% = \$.0825 to student aid
  - 75% = \$.2475 to restock hygiene products and school supplies
- Any unspent money would go to USAC Surplus

Isabel: how much would this generate a year?

- Around 24k a year
- Lalo motions to put Good Clothes Good People Referenda on ballot, Kelechi seconds
