IV. Public Comment

Nicholas: I urge USAC to pass the resolution in support of the Burmese students and the people of Myanmar. I believe it has become increasingly difficult for the students in Myanmar to maintain their studies as the country is breaking apart with the constant internet cut [indiscernible] and how people have to focus on their families as well. I think it's important for UCLA to stand behind the students and that public statements should be released by the school so that more people are aware of the situation that is going on in Burma, and even though they're giving students enough resources, I believe that a public statement is necessary in order for things to progress further. Thank you.

Luke: Hello, good evening council. My name is Luke and I also urge USAC to pass the resolution in support of the Burmese people, the Burmese students and the people in Myanmar fighting against the military [indiscernible] right now. Just [indiscernible] the effects of the coups on UCLA students, a lot of students like Nicholas said have been unable to focus on their studies as much as they could, given the very frequent internet cuts happening in Myanmar right now. In terms of that, so students not only have been struggling with their studies, but with their families and Nicholas has also mentioned, a lot of people in the country are unaware of the military coup happening in Myanmar right now which has gotten so bad that there is currently more than 770 civilian casualties right now and there has been so much hurt, violence, and bloodshed on the people of Myanmar. So I am here today to urge USAC to pass the Resolution in Support of Burmese Students and the People of Myanmar, not just for the Burmese students at UCLA, but also for the civilians of Myanmar fighting for their futures.

Justin: Hello, I'm speaking in my capacity as an individual right now. Speaking in support of Palestinians being hurt and killed by Israeli right wing forces. What is happening right now is present day colonialism and settlement in a neighborhood in Jerusalem, as well as bombings that are happening in Gaza. I think media in the U.S. right now is showing out in support of Israel

and kind of switching what the real situation is including terrible takes on Twitter by Andrew Yang among others about really what this is. I don't know that there's much that we as a last council can do, but I urge the next council to consider, like we have set precedents for supporting students during traumatizing experiences overseas, considering a resolution to urge for academic leniency among other things for Palestinian diaspora students. Also I wanted to plug a protest happening at 11000 Wilshire Blvd on Saturday because it is also the anniversary of when the first settlement of the Israeli project really began. Thank you.

Bakur: I'm also speaking as an individual mainly to focus the attention of not only the new council but the wider student body who might be listening. The past few days, as a Muslim, as an Arab, and more importantly as a human, they weren't the easiest days. Innocent people, kids, and women getting killed. Not only the holiest month for Muslims, but even days. People start fasting in the morning, but before they can break their fast, they are dead. If there is one regret that this is my last meeting, is that I cannot no longer do something in my capacity as a council member, so I do really hope that the next council can do something about this. While what's happening is on a greater scale than usual, but it is not something that is happening for today or for tomorrow, for a few days. It's something that has been continuous for like seventy years. We don't always get to listen or to hear about what's happening just because media doesn't generally cover it, the reality is that it's a continuous struggle for many students. We do have a good population of Middle Eastern students and Muslims and specifically Palestinian and many of their allies. It's not only something for now, to provide support for what those students need, but it's something that I think the new council may need to look into more structured support for those students going forward. That is mostly what I wanted to say. I do really hope that the new council members will listen to this and if they're not here, then they would get to hear about this. Thank you very much.

Arsh: Very good evening to everyone present here today. My name is Arsh, and I'm here in my capacity as a member on the ASUCLA Board of Directors to share some updates over the past couple of months with the undergraduate student body. In terms of updates, we have recently approved a Diversity and Inclusion Statement of ASUCLA in it's 100 years of history which is a great thing of pride. The marketing department is launching computer bundles with the Westcom technology loan in order for students to have access to any technological equipment they might need in order for them to continue their education with the least trouble. The Student Union Operations Department is also in the process of developing a business model for an E-Sport lounge that is potentially going to be coming in the Ackerman Student Union. Finally, I wanted to share that management is also in the process of updating the Point of Sale systems in our UCLA Store and all on campus restaurants operated by ASUCLA which will soon be equipped to accept CalFresh, SNAP, and EBT benefits in order to address food insecurity on campus. It's estimated that this will come into effect very soon. Finally, I just wanted to take a moment to extend my appreciation to the outgoing council for all of your effort over this past year. In a time where everything was stacked against us, your resilience made accomplishments that would have been a reach today. Not to forget the various collaborations that we've had this year, the good times including advocating with Gen Rep 2 and Facilities Commission to promote ethical and sustainable labor practices, working with IVP to host the first ever Mask Design contest, and FSC to distribute all \$313,000 in Covid Relief Funds to students, which is an insane feat. Including, but not limited to, collaborating with the Office of the President to shed more light and transparency on UCLA student fees. All these accomplishments certainly set a promising precedent for the continuous energy between ASUCLA and USAC, I am personally very excited to see how it develops in the coming years. Thank you for trusting me, and Naomi, for appointing me as one of the 2020-2021 Undergraduate Representatives, it has been my honor to serve in this capacity and to redefine the Bruin experience. One final comment, ASUCLA is open to every member of the Bruin community for life, not just to students, even as alumni you are as much welcome into the space and you have as much of a stake as you do right now. I would like to welcome everyone regardless of whether you are a student or an alumni, and finally I wish you all the best in everything ahead. Thank you.

Resolution to Abolish the University of California Police Department*

A Resolution to Abolish the University of California Police Department

WHEREAS, Black Panther and current political prisoner Mumia Abu-Jamal states:

Abolitionists are, simply put, those beings who look out upon their time and say, "No."

They want to abolish state policies that they cannot abide. Slavery. Mass Incarceration. The death penalty. Juvenile

Life. Solitary Confinement. Police Terrorism.

Those goals are worthy of the name. Only the fire and will seem to be lacking.¹

Let us recover their vision-and build new ones that soar towards the bright morning of Freedom; and

WHEREAS, the oft-referenced charge of police is "to protect and serve," yet police frequently act against that charge in surveilling Black people, suppressing labor organizing, and in general, engaging in white supremacist violence; and

WHEREAS, as stated by Mariame Kaba, "efforts to solve police violence through liberal reforms…have failed for nearly a century…The only way to diminish police violence is to reduce contact between the public and the police"²; and

WHEREAS, there is no substantive distinction between the University of California Police Department and local police departments. Policing at the UC began with Berkeley Police Chief August Vollmer in the early 20th century, who took lessons he learned from the Philippine-American War and applied them to policing, earning him recognition as "the Father of Modern Policing",³ and

WHEREAS, a report by Civilytics Consulting called *Policing the American University* drew observations on the role of campus police departments in policing the boundaries of campus and surrounding communities, policing Black students and community members, and having origins in suppressing campus movements back in the 1960s;⁴ and

WHEREAS, UCLAPD currently spends approximately \$21 million⁵ dollars per year on the police department, with approximately 60 sworn officers and 40 non-sworn. This budget has steadily ballooned since the 2008 Great Recession, when many student programs were cut and tuition was raised;⁶ and

WHEREAS, a report released in April 2021 noted that "less than 10% of [UCPD-related] events [at UCLA] involve either force or the threat of violence...and more than 80% do not result in follow-ups for any asserted or possible crime"⁷; and

WHEREAS, Million Dollar Hoods found, through combing and cleaning UCPD records obtained via California Public Records Requests, that Black and Latinx Westwood residents were 19 and 2 times more likely than white residents to be stopped by UCPD; and

WHEREAS, in 2011 during the Tuition Hike Protests at UC Davis, Lt. John Pike doused several seated students at point blank range with pepper spray, and began a UC-wide and nationwide conversation about campus police reform;⁸ and

WHEREAS, in 2020 UC Santa Cruz deployed officers to police the Wildcat Strikes, organized by grad students for COLAs, at the cost of hundreds of thousands of dollars. UCPD also utilized military surveillance technology provided by the California National Guard and the FBI to monitor students' movements;⁹

WHEREAS, according to *State of Crisis: Dismantling Student Homelessness* by the UCLA Center for the Transformation of Schools found that 1 in 20 UC students are homeless or have experienced homelessness at some point in their college career,¹⁰ and

WHEREAS, Counseling and Psychological Services, the department providing students with direct psychological treatment, and the RISE Center, the department providing students with preventative care, are chronically underfunded, with 80 counselors serving a population of over 30,000 students and having to rely on frequently outsourcing services;¹¹ and

WHEREAS, students deserve to have their basic needs met and to have adequate access to healthcare, not to have resources funneled away into a bloated police force; and

WHEREAS, after the summer 2020 Black Lives Matter uprisings and the detainment of protesters in the UCLA-leased Jackie Robinson Stadium, the USAC joined the Divest/Invest Faculty Collective in a boycott of UCLA's proposed Public Safety Advisory Council on August 26, 2020 and demanded the creation of a Divest/Invest Council to examine where police funding could be best reallocated to support true campus safety¹².

THEREFORE LET IT BE RESOLVED, that the USAC stands in solidarity with Black, Brown, Indigenous, formerly incarcerated, and system impacted students who are disproportionately surveilled and criminalized by the UCPD.

LET IT FURTHER BE RESOLVED, that the USAC calls on university administration to entirely abandon expansions of campus police, outlined in proposed policies known as the "Gold Book," and listen in good faith to student demands, and put those demands into practice.

LET IT FURTHER BE RESOLVED, that the USAC supports the demand of the No UCPD Coalition in defunding UCPD to be redirected into CAPS and RISE funding, as well as severing connections between UCPD and mental health crises.

LET IT FINALLY BE RESOLVED, that the USAC calls on university and systemwide administration to affirm the humanity of its students, staff, and faculty and heed our calls to disarm, defund, and abolish the University of California Police Department.

WHEREAS, the national elections have concluded and declared the ruling civilian party, the NLD, as the legitimate winners yet the military has refused to accept the outcome; and

WHEREAS, the Myanmar military (hereinafter referred to as the "Tatmadaw") staged a coup against the civilian government on February 1, 2021; and

WHEREAS, the Tatmadaw has declared a state of emergency and installed an interim President from their party for one year, neglecting the democratic will of the Burmese people, and threatening to erase years of hard earned progress in democratic reform that Myanmar has achieved; and

WHEREAS over 700 civilians, including children, have been murdered, over 4496 have been arrested arrested since coup and over 3448 have been detained and/or sentenced by the Tatmadaw since the February coup; and

WHEREAS, the newly installed military government have closed banks and frozen financial transactions, leaving students and their families unable to access funds, and jeopardizing their ability to continue their studies across UC universities; and

WHEREAS, the newly installed military government have imposed a communication blackout cutting off internet connection among other means hindering the ability of students back there to view course material, complete assignment, or attend classes; and

WHEREAS Burmese diaspora students in the United States face high levels of stress and anxiety due to the uncertainty of the current and future well-being of family members and/or people of Burma back home; and

WHEREAS, Burmese students in Burma face extreme country conditions, such as the threat of the Tatmadaw entering their homes and threat of being shot or arrested wherever they go, that complicate their ability to keep up with their studies; and

WHEREAS, Burmese students face an increasing frustration with the lack of public support of the Burmese people and its peaceful struggle for democracy from their respective academic institutions; and

WHEREAS, UC Los Angeles, has provided the necessary academic, financial, and mental health relief and resources for its Burmese students; and

FURTHER LET IT BE RESOLVED, UC Los Angeles continues offering support through these difficult times and actively facilitate the different accommodations Burmese students need with other departments and entities inside UC Los Angeles; and

FURTHER LET IT BE RESOLVED, UC Los Angeles allow affected students flexibility with P/NP grading; and

FURTHER LET IT BE RESOLVED, UC Los Angeles calls on the professors teaching the classes of the affected students to show empathy and patience; and

FINALLY LET IT BE RESOLVED, UC Los Angeles reaffirms its support for Burmese students.

WHEREAS, The Board of Governors for the California Community Colleges have started the initiative to incorporate two student representatives prior to the COVID-19 pandemic;

WHEREAS, The student regent is the foundational access point into the realities students face;

WHEREAS, The student regent helps guide the Board of Regents to advocate for policies that align more closely with the struggles the students incur;

WHEREAS, Student regents undergo a thorough and competitive recruiting process involving an application and multiple interviews to ensure their dedication to the position;

WHEREAS, Student regents have a one year "student regent-designate" position in which they shadow the current student regent which gives them the expertise and knowledge to effectively serve as student regent the following year;

WHEREAS, Several board committees meet simultaneously and conflict with student schedules;

WHEREAS, Students would have more opportunities for recognition at discussions of different committee agendas;

WHEREAS, the Government Relations Committee of UCSA recently endorsed SCA 5;

THEREFORE LET IT BE RESOLVED, the USAC calls for the permanent designation of two voting seats on the Board of Regents for students;

LET IT BE FINALLY RESOLVED, that the UCLA Undergraduate Student Association supports California Senate Constitutional Amendment No. 5 and calls on all levels of UCLA administration to support it as well.

A Resolution in Support of Federal Support for the BruinHub Commuter Student Project* Arasasingham A RESOLUTION IN SUPPORT OF FEDERAL FUNDING FOR THE BRUINHUB COMMUTER STUDENT PROJECT

WHEREAS, there is a true need for commuter student and houseless student support from the university;

WHEREAS, Westwood, the closest living community to the UCLA campus, has the highest average rent prices in California, forcing many students to live further from campus to save money;¹³

WHEREAS, a super-commute (defined as a 90+ minute one-way commute) is a constant reality for at least 18% of students who live off-campus;¹⁴

WHEREAS, almost half of students experience housing insecurity and 15% of students face houselessness during their undergraduate career;¹⁵

WHEREAS, these issues are exacerbated by the COVID-19 pandemic, as many students face increasing care responsibilities, higher costs of living, and difficulty accessing public transportation;¹⁶

WHEREAS, UCLA has committed to returning to predominantly in-person instruction, so most students will need to report to campus to receive and excel at their education;¹⁷

WHEREAS, the issues of long commutes and houselessness disproportionately affect Black, Indigenous, and People of Color (BIPOC) UCLA students;¹⁸

WHEREAS, the BruinHub project is an innovative support system intended to be installed in the Wooden Center that will address the growing super-commute problem by providing a space for commuter students to safely study, relax, and sleep;

WHEREAS, the school will provide students with individual 'study beans' as a prototype, with plans to expand based on student responses to the project. These 'beans' provide private individual space for students to sleep and work;

WHEREAS, the BruinHub project is just one of many necessary initiatives that UCLA can and should implement to support commuter students, particularly those facing housing insecurity. Other important initiatives that deserve funding and recognition include the Safe Parking at UCLA initiative, rent relief grants, transportation support grants, and increased affordable housing provision;
