IV. Public Comment King

- Clara: "Hi I am Clara and I am the CALPIRG Chapter Chair and our quick update on what we're doing this quarter. First, if you haven't heard we actually won our campaign last quarter to get LA County styrofoam free which is really exciting and I want to shout out that one of the things we submitted to the city council was the Youth AC resolution so thank you so much for contributing. Right now we are having our winter recruitment guide to get lots of new students involved this quarter. WE are doing a bunch of cool events for our campaigns and also giving announcements in classes. So far we have made announcements in 20 classes and have over 100 students interested in getting involved already so that is exciting. WE are going to be running three different campaigns this quarter. We are working on a new environmental campaign to protect our oceans so we are calling on Governor Gavin Newsom to make 30 of California;s Waters Marine protected areas which are sort of like national parks but in the ocean. We are also going to be continuing our work on plastic pollution but with a corporate campaign to advocate for Amazon to start shipping plastic free in California and then we are going to continue our basic needs campaign from last quarter advocating for Open Access textbooks at the UC. We are also going to be working with our homegrown homelessness campaign to partner with the LA City Council to try to get more policies passed in LA. Lastly, our basic needs campaign is putting on a benefit concert on Friday. It is going to be super cool with lots of student performers. I am going to post the RSVP link in the chat if you want to share it with anyone but yeah, thank you so much for having me. I hope you guys have a good meeting."
- Bradley: "Hello, my name is Bradely and I am the external vice president of IEEE at UCLA which is the largest electrical engineering club on campus. I am here to express my grievances accessing funding for our hackathon event that we have been organizing for several months and it is taking place in less than two weeks. This hackathon is an

incredibly valuable resource for hundreds of students to gain hands-on engineering experience that they cannot get anywhere else but the complete lack of responses from on-campus funds have really stopped our ability to provide this resource for students. We are specifically waiting on money from BOD, ARC, and ASRF which is vital for several large orders with both on and off campus vendors that need to be finalized in the next two to three days so by the end of this week and I am really anxious about the compressed timelines induced by the delays in these funds. We need payment for our venue Ackerman Grand ballroom by next Wednesday which only leaves one week from today to receive our allocation, submit the paperwork and have GSA process it. Catering from HCAA requires us to finalize our order by the end of this week and I am not able to do so until we know what our budget is. I am really anxious about these timelines since just a few days is significantly less than the several weeks GSA recommended giving to process the paperwork. BOD is one of the primary funds for our event and it is unacceptable that we were uninformed that we would be receiving our allocations only this week after applying two months ago. We need to receive this allocation in the next two to three days which you were told but I am not sure if that is going to come through to meet the deadlines. ARC has only ever responded to me once and they informed me that we have funding but that it has not been finalized. They haven't replied to any of my emails over the past month. ASRF unexpectedly closed last quarter and they told us to reapply this quarter so I did that this morning and I am just requesting here that they expedite our application just to get that moving forward. Overall, just the lack of communication and consistent delays is really hindering our ability to support this resource for hundreds of students who will be attending our hackathon. I am doing my best to consistently communicate our needs over email. I understand that those who are managing these funds are students but I don't know what to do at this point after just not receiving responses from these funds."

Michelle and Hannah: "This is Michelle and my name is Hannah and we are the SUE Outreach co-directors and we are having a similar issue to Bradley. First off, we did want to thank you guys for hearing us out because we know that this isn't as important to you as it is to us but we are aware that USAC has had delays. We are trying to put on two different events this quarter involving outreach to elementary, middle, and highschool students both coming to campus and virtual and to do this we want to offer them food and activities in different rooms and facilities across campus so we want to be aware of how much funds we actually have and because we really do want to empower and diversify engineering. We are concerned about the Community Service Mini Fund and ARC. We have not applied to these funds yet because we have heard there have been some issues with them. We will submit them very soon but we were just wondering what the timeline looks like for these funds and just an update on them overall. Thank you."

Then for events from week 6 to finals week the application will open Monday January 16th and it will close January 27th and then the hearings will be completed by Friday of week 5 which is February 10, 2023. Again I am so sorry, it is just out of our control with the amount of people supporting ARC at this moment but hopefully it will be resolved in the early half of winter quarter."

Just one quick report or update that I should say is that SOLE is currently this week and next week registering new organizations so if you are thinking of starting a new group or know someone that wants to do this please send them our way. Or if they forgot to re-register last quarter, so this is also a new opportunity for those that missed that deadline because I know there are a few out there."

- Jessica: "Hi everyone, I just want to give you a little more background information on the USAC website. Obviously really awful timing for this to happen but you know these things happen and we work through it and we try to get to a solution. So right now we are still not 100% sure how or what got hacked. We think it was through our cpanel server which is how we host the USAC website so basically UCLA IT services shut down everything so that if there is an ongoing threat that we essentially put a stop to it and prevent it from further attacking other sites that are also on that same server. Unfortunately it also indirectly impact the TGIF website for example which is down currently so we have a temporary solution to get the site backup and hopefully we should see that happening in the next day or two and we are working with UCLA and ASUCLA IT folks to figure out a solution going forward because we do want to address those security issues and so if we think that this is going to take longer than another day or two to get the site back up we will just have to deal with how we publicize funding links and like the rec form direct link so that all students can still access it without having the website up and functional so I will be thinking more on that and you know how we can have those links available in an alternate location. Hopefully I will know more tomorrow and can give you all an update by email and then the other thing that I was going to mention, if you have space on your agenda next Tuesday I would like to have Mary Romo who is our new programming manager for ASCUAL come to not necessarily give a presentation but just an introduction to you all so you get to know her and see the kind of things that she is working on and also you know to open the opportunity to co-program with ant of your offices. If there are any ideas you have for programs and services that you want to see in the union, Mary really is our lead person facilitating that. It is a new position that ASUCAL did not have before so this is a really great time where we can be creative. Lastly, I was going to update you all. I was able to find in my email some record of when we did an electronic meeting to vote on the funding so basically you know best practice would be to follow your bylaws to notify the public 48 business hours before the meeting so the earliest you could do it if you want to call it tonight would be Friday morning if that works. Essentially, you set up a two hour window to receive votes and then Carl would send out the email with the attachments for the funding and any details and then for quorum, carl's initial email will count as one person and then you would need nine additional vote to have a quorum of 10. Majority vote would pass the funding allocations so you can do it that way if that is going to work out to get the BOD funding approved before any events occur. That would be my recommendation to move forward if you are in a pretty tight deadline in terms of needing to get it done before next Tuesday and I will go ahead and email that to you Carl so you can kind of see how it works."
