# C. External Vice President

- Evan and I met with Bruin Shelter about the Safe Parking Initiative. The next steps are to initiate a coalition partnership. This was an initiative that failed the first time but really worked to get this running.
- Also want to begin conducting a financial analysis to see how much this would cost. We have one from 2020 but we know that this is outdated and will be a lot more money now. Reaching out to facilities to see what the capability is there.
- Also looking to see for hygiene access.
- Planning to review previous bills to see what state bills would make a provision for safe parking look like, and what type of funding that would be available.
- Attended long-term planning meeting for Basic Needs Coalition, seeing how to address policy goals
- Also going to issue a trigger warning for sexual assault. I met with UCLA IGNITE which works on reproductive rights. We discussed issues that we want to target UC Regents for. We want to fund for CARE Directors. There is supposed to be one CARE Director of 13,000 students, but that is not the current situation.
- Also looking for nurses who are trained in sexual assault care specifically.
- Discussed the issue of funding for transportation to hospitals. There is a bill that passed the state assembly that provides funding for survivors to be transported to hospitals within a certain radius. UCLA is covered under the bill. This affects UC's that are not close to hospitals though. Seeing how we can work around this.
- Planning to meet with ASA that presented the resolution last week. Thinking about a student-led mobilization that can work for the divestment of this project.
- Met with END OVERDOSE to see how we can get easier access to Narcan and fentanyl test strips.
- Met with CALPIRG to talk about the New Voters Project. They would work under the Bruin Vote Chair, discussing a vision for this. Having democracy workshops and institutionalizing support for helping people understand their elections.
- Setting up a meeting with Mick DeLuca to speak about this issue
- Also met with the Deputy Director of Campus Life and discussed Bruin Vote stuff and they helped to break down the UCLA Bureaucracy.
- Met with the Facilities Commission to speak about a labor coalition. With UCSA and a movement for sustainable labor. Making it a UC Wide policy where you can't sell from companies that have labor violations.
- Attended a meet and greet with Pouria and that was super informative.

So one of our folks from our marketing team, Christina, reached out for content for our four pillars newsletter which is an internal ASUCLA newsletter that features content from all four entities that we send out organization-wide and to other folks on campus so if there are any specific initiatives that any of your offices want to highlight or if you would like a quote that you want to give, we can also include that in there. Feel free to respond back to that email or just let any of us know if there is content that you would like us to include. It is all due on Friday by probably 4 or 5 pm. I also wanted to mention that for Wellness Wednesday tomorrow from 11-2 pm in the Fun Zone on A level we are doing crafting and we are also giving out meal coupons so ten dollar meal coupons. First come, first serve until they run out. I also mentioned last week but our study cafe which is our little finals week pick me up we are distributing blue books and scantrons. I am also going to be giving out 10 meal coupons so that folks who are not in Ackerman for that event can still pick up some food or snacks. That is it for me, thank you."
- Steven: "Hi everyone, I am just going to quickly introduce myself because I think in my absence, we have already transitioned. My name is Steven. I was at UCLA for 10 years, 4 for my undergrad, and 6 years for my Ph.D. so I have quite a lot of institutional knowledge. I was involved in a lot of capacities during my final years. I was on the board of directors for ASUCLA and I have also been involved in the academic senate and stuff like that. Beyond my alumni capacities, I am more than willing to talk to anyone. I am a completely open book. I have probably had the same frustrations that you might have at some point during your time at UCLA and so if you ever want a safe space to discuss issues that come across, I am more than happy to talk to you about that. I will say that since I finished my PhD this year, I have been more busy than I expected and that has kind of prevented me from coming to all of these meetings. I recently got married and I just had my honeymoon so I have been gone for the past month but work has also been crazy. I am looking to try to transition to be a little bit more involved in the next year and trying to be more responsive. I think one thing that was brought up about nominating new members to the ASUCLA BOD, I just wanted to point this out because it was an issue this past year but I don't think everyone always realizes how much power the members of the board of directors have and so I think you should just really keep this in mind when you start looking at candidates to assume this position because they can actually make financial decisions that superseded USAC. This is not just another nomination, you should really consider the implications and take this nomination seriously. I also am just going to bring up the discussions of starting an alumni network. In order for that to really happen we need some dedicated champions, most likely alumni, that are willing to kind of be this initial team leadership for that organization and so if this is something that you are interested in, I am more than happy to work with you to set something up. I also think there was some talk about doing something on the CEC side and so we can also discuss something on that end as well."

- Lori: "Today, I had a wonderful time. I got to learn a lot about Jonathan. I also just gave this information to Naomi last week in the staterooms but I think you should keep tabling for appointments. This is a great way to capture a bunch of incoming students that might be interested in this opportunity. If you have any graphics, let me know and I will have UCLA Rec share it on our networks as well. I also have a meeting about Bruin Bash. Tomorrow Evan and I are going to talk about Wooden and Sunset Rec facilities. If you need anything else, reach out to me."
- Jonathan: "I have said this before, but I will say it again. If your predecessor has outstanding bills please follow up with them. The only one that I haven't heard back from is CSC and to my current knowledge, this may be different so we can talk about that individually. The ones that I have heard from but are not yet complete are CEC and ISR. I will do a separate audit of that tomorrow morning so if that is incorrect that is okay. If you have any problems with your office, let us know. If you have big things you need to move out, let us know. We are here to assist with that. Just a general note on appointments, BOD is extremely important and absolutely we should be focusing on filling those three positions. There is one singular one-year term because one of our current members is graduating early. I do want to encourage you, I know that there is a lot going on right now, but this is your last time to have face time with students before summer so really be thinking about your other appointments. A vast majority of these are going to be filled in the next month or two so really think about that. We got a request from Megan for help with advertising so there is a couple of ways to go about this. The first is, if you are posting on your own if you tag @asucla, we will automatically repost it. If you want us to initiate the post, we need details of what you want us to post and what you want us to say. Then I will submit a marketing request to our marketing department to do those things. Thursday is our Meet the Admin mixer at noon in the staterooms. I really really really want to encourage you all to prioritize this. I know that it is week 10 and I know it is hard to get there in the middle of the day but really try. We have about 25-30 higher-level admins that have RSVP'd that are going to come on Thursday to speak with you and I'll be frank. #### G. Discussion to Amend Bylaws to Include Transfer Representation in each USAC Office

- Thyra: "Yeah, I don't really know how to facilitate this discussion but I just want to raise the concern and just talk about having each office focus on transfer issues. I know transfers are literally one out of three students here and that means I have a lot of students for me to represent I don't understand why there has not been a change to all of your office already but I think it would just help me to engage with your offices and realize whether I didn't collaborate much with any other offices that were doing anything with transfers. I don't really know what else to say outside of that but just working to collaborate more with the TSRs and also just like creating a transfer representative in each of your offices and having a Transfer Community Council as a space. I have already tried to start to do something like that with other offices but I would love for staff members to be involved with that because it is just a lot to do this all alone. You would also use that director as a liaison between me and your offices where we really have open communication. It would also help to alleviate the stresses around funding because like last year I came in as the TSR halfway through the year and it was only like \$5,000 dollars and I had to support the entire transfer population with that and that is not enough."
- Jonathan: "I absolutely agree that it needs a lot of support and I think that each of our offices can help out in that space but that being said, I don't think that having each of us have a representative is the best course of action just because I think that it wouldn't have a merit to try to force this in the face of each office. But I do think that we can prioritize to have a transfer applicant enter into our offices and then of course gear some of our events for transfers and collaborate in advance but I don't think amending the bylaws is a requirement for us to have transfer representation in our offices. As you mentioned, it is one-third of the population, which leaves 66% of the student body that we also have to represent. I absolutely agree that it is important to support transfers and they have demonstrated a significant example of resilience and discipline to be accepted to UCLA, but we also need to ensure that we are supporting all students equally."
- Thyra: "One thing I understand is that we are supposed to support all students but I have noticed that we support our students by having a general language around students but as a transfer person specifically sometimes we don't feel like we are welcome if it is not specifically for a transfer student. I am not going to force any of you to have a transfer representative but I will put emphasis on the big ones like president or FAC, but I will leave that up to you all to decide and do your own research on."
- Evan: "Really quick, I appreciate you bringing this up and we really want to make sure that we are supporting transfer students I know that in the past they have been left behind so we can really work to correct that moving forward. I think one thing for me when it comes to the facilities commission specifically, I think it would be very wise for all of us to hire a member of the transfer community so we know exactly the issues that they are facing and we can make sure to incorporate that into our offices. I think just having a transfer representation is a way to look inclusive which is great, but maybe having more action-voting things going on in the future would be good. I talked about maybe having a transfer student checklist. I think that would be

very helpful to have a list of actionable items that we are working on. I will also say I know you mentioned collaboration and we are open to collaborating on events and other things. I will definitely think more about having a transfer representative in the office but thank you for bringing this up."

- Naomi: "Thank you so much Thyra for bringing this up. I think it is incredibly important and I really resonate with what Evan shared. I think a transfer representative might not be the most suitable for all of the offices although it would really work well for some but I think all offices should try to have an event or a really targeted approach to make sure that they are accounting for transfer student interest. I know Alicia put it in the chat and said that she would love to have an art series to host transfer student experiences. I would really push for everyone to look at your events and think about how you are working to incorporate transfer students."
- Sujana: "I just want to echo what other people have said and I just want to say thank you so much for bringing this to our attention. I see your Instagram and I see the things that you do, you do so much for transfers and I just know that you are a really important symbol in our community. I also have to go along with what other council members have said in that I do think codifying a position can be difficult because I had to remove director positions this year to make sure the office was well organized. However, I do think we can all have events and make sure we are doing programming that is catering to transfers. I see the importance of what you mentioned about the Transfer Unity Council. I do see the importance of designating specific people to make sure that these issues are being thought of because we can all collectively say we want to program for transfers but if no one is specifically looking out to make sure these things happen it can be hard. I feel like something we can all do as a council is we can discuss this later and see what we can do about incorporating more transfers into our offices."
- Eva: "Thank you for bringing this up Thyra. I think when I am thinking about the EVP office specifically. Last year we were really fortunate to have a solid amount of transfers around but there is still obviously more that we could do. I think we could get together to discuss policy ideas because you know I am telling this my chief of staff that I am onboarding tomorrow and that my biggest goal for the office is to make lobbying trips more accessible and have more of them because we live in LA and there are so many people we can get to lobby on all levels of government and I think by ensuring that transfers are in that room would be great."
